

CAMP RULES & CONDITIONS OF OCCUPANCY

- Accounts :** Balance of accounts are payable on arrival.
Payment must be made for the full time booked.
Refunds for early departure are at the management discretion. Refunds will only be considered in exceptional circumstances.
- Arrival & Departure :** Arrival time 2pm unless arranged otherwise.
Accommodation will be held up until 4pm on the day of arrival unless a full nights deposit has been received.
Departure time 10am.
- Caravans :** Caravans and campervans must have a current electrical warrant of fitness (EWOFF) and comply with LPG Standard (NZS 5428:1996).
All campervans and caravans must have their own wastewater container.
Chemical toilets must be emptied in dump stations.
- Children :** Children are to be controlled and supervised by parents at all times.
- Conduct:** Reasonable quietness between 10.30pm and 7am. Some discretion is allowed on New Years Eve.
Reasonable behaviour and dress at all times.
No liquor to be consumed in park except on own site or in accommodation units. Excessive drinking and parties are forbidden.
Consideration must be shown at all times to other guests.
- Damage :** Cost of damage to property or accommodation will be recovered from the registered camper.
No responsibility for damage or loss of personal property in the holiday park will be accepted by management.
All property stored on the site is entirely at the campers risk. Insurance is the responsibility of the site holder.
- Dune Care :** There are extensive new plantings on the dunes at the front the camp. This is a joint initiative between the camp owners and the Opotiki District Council. The dunes are our most effective protection against coastal erosion.
Please take care to use the marked beach access ways at all times.
- Parking :** One vehicle to be parked on own site only.
Parking is not allowed on driveways.
Boat & trailer parking is in designated area only.
Vehicle washing to take place in designated area only.
- Pets :** Pets may be admitted by pre-arrangement ,at management discretion.
No pets are permitted during peak times.
- Rubbish :** We are a CLEAN GREEN, 100% WASTE FREE camp and request campers to strictly observe our recycling programme.
Sites are to be kept clean and tidy at all times.
Rubbish is to be sorted and placed in the marked bins at the rear of the mens toilets in the main block.
If you do not wish to sort your waste please take it with you.
DO NOT PUT BONES, PLASTIC ETC IN THE FOOD BIN.
ALL FISH WASTE IS TO BE DISPOSED OF IN THE SEA.
- Smoking :** Smoking is not allowed in any accommodation or buildings.
- Speed :** Vehicle speed in park is limited to 10km/h
- Swimming Pool :** Children under 10 must be ACTIVELY SUPERVISED by a CAREGIVER 16 or over.
ACTIVELY SUPERVISED means watching your child at all times and able to provide immediate assistance.
All pool users must observe the pool rules posted in the pool areas.
Parents are responsible for ensuring children observe the pool rules at all times.
- Tents :** Electricity must be connected through RCD Safety Switch, and display an approved “electrical safety Tag”.
- Visitors :** Visitors must report to the office on arrival.
Visitors are the responsibility of the registered guest, and should depart by 10.30pm, unless arranged otherwise.
Visitors vehicles are to be left outside the park or in the visitors car park.
A day charge may apply.
Any charge for visitors, if not paid, will be the responsibility of the registered camper.

We ask for your co-operation so that your stay and the stay of other guests is enjoyable.

Breach of any of these rules, Health & Safety, or Fire regulations may result in you being required to leave the park immediately without refund.
